Breeding contract for the 2010 season

The following agreement is made between Heath and Kellie Stewart Saltriver PTY LTD T/As Saltriver Performance Horses.

1. The service fee to Kirkbys Stud Jericho (will be known as the stallion) for the 2010 breeding season will be \$1100.00. A booking fee of \$330 is required this is deductible from the service fee but not refundable.
2. The handling fee for the breeding will be \$330.00 this will cover two cycles and for every cycle there after will be \$110.00 natural and fresh cover.
3. It is the owner's responsibility to have the mare pregnancy tested **if** the mare has left the stud for a 42 day pregnancy test and notify the stud manager by way of veterinary certificate confirming pregnancy. However we recommend the mare be scanned rectally around day 19 – 22 to check for twinning. All mares remaining at the stud will be Preg tested at 14days.
4. In the event of the pregnancy being reabsorbed the mare can return to the stud as a free return (handling fees and agistment will apply).
5. Service record will be held by the stud and breeding certificates will be issued to the mare owner.
6. Registration forms for the Australian Stock Horse Society will be available to the owners on the birth of the foal. Owner's responsibility to notify the stud
7. The method of payment can be in the form of personal cheque, bank cheque or cash
8. The method of service will be hand service only.
9. FSH and Ovulating enhancing drugs will be used
10. All mares whilst at the stud will be pregnancy tested between day 14 and day 19 of their cycle post service. This cost will be incurred by the owners. If the mare is preg tested positive at this time an invoice will be raised for the cost of the service fee.
11. In the event of twins being detected, the owner will be notified and the cost of twin ablation will be at the cost of the owner.
12. All other costs incurred eg: follicle tests, pregnancy tests, or any other veterinary treatment required will be at the owner's expense. will be charged directly from The Horse Hospital, Ascot, Dr Mike Davies.
13. Agistment is available This will be invoiced to the owner at the end of each month and payable 14 days thereafter(costs are displayed at the end of this agreement)
14. All mares must be swabbed by a vet and return a negative result prior to service. This certificate must be shown on arrival at stud.
15. Van servicing Mares must have proof of being currently covered for EHV1, 4 and strangles. If mare arrives at stud with out certificate of proof mare will be vaccinated on arrival at owner's expense.
16. Agisting mares will be vaccinated on arrival to the stud at the owners expense by the attending

17. veterinarian each mare will receive a mandatory EHV1,4(Duvaxyn) strangles vaccination and deworming
18. All wet mares agisting with foals over the age of 5months the foal will also be vaccinated against EHV1, 4, Strangles and dewormed at the owners expense.
19. All mares will be cleaned with appropriate disinfectant prior to serving and have their tail bandaged.
20. The stallion will also be guaranteed not to carry any infection and will also appropriately cleaned prior to service.

21. Mares may have to be twitched and or fitted with breeding hobbles at time of service.
22. Live foal guarantee is until the foal is twenty four hours old standing and suckling. If foal dies at 25 hours LFG is void.
23. Foals that are born deformed that require euthanization, the mare or substitute mare may return to the stallion(at the stud managers discretion)
24. Foals born with a life threatening illness that also requires euthanization the mare or a substitute mare may be returned to the stallion only if the owners can confirm that nothing in the mare's management contributes to such an illness.
25. The owners of the stallion Saltriver(WA) PTY LTD reserve the right to refuse service to any inappropriate mares.
26. No responsibility will be accepted after the mare has left the stud
27. I understand and agree Saltriver Performance Horses, Heath and Kellie Stewart and their employees will not be responsible or liable for accidents ,sickness, death, injury or disease to my/our mare or foal however they will take all reasonable precautions in their care and supervision,
28. This contract will only become void in the event of the stallion's death or if the stallion becomes sterile before the event of breeding therefore the **service fee** will be refunded in full.
29. In the event of the death of the mare during the gestation period the owner of the mare still owns the service and another mare may be bred on the approval of the owners of the stallion.
30. The service is not transferable.
31. In the event of an injury or sickness of the mare whilst at the stud, the owner will be notified immediately to ascertain treatment.
32. In the event of the owner being uncontactable, the manager of the stud will seek correct appropriate veterinary treatment from the veterinarian of the stud's choice at the owner's expense.
33. This contract becomes binding upon signature of both parties.

34. **Chilled Semen** – the stallion service does not include collection costs – the cost is \$165 per collection plus shipping costs.
- 33(A) Shipping container deposit \$38.50
- 33 (B) The quality and quantity of semen shipped is deemed to have sufficient numbers and motility to obtain pregnancy under normal conditions if inseminated within 24 hours of collection.
- 33(C) The mare owner agrees to engage in the services of an experienced Veterinary Surgeon or a qualified Equine AI breeding Technician, during each breeding cycle of the mare so to enable maximum fertility.
The mare owner shall have the mare examined by a licensed veterinarian surgeon for pregnancy at 14 days and 42 days from the last insemination, and provide a certificate of the result of such examination to Saltriver Performance Horses within 7 days of examination. Should the mare fail to fall pregnant after 2 cycles with either frozen or chilled semen , she may (at the discretion of the mare owner) be bred naturally. All extra costs involved will be the responsibility of the mare owner.
ANY CHILLED SEMEN WHICH IS NOT USED to breed the mare under the contract must be destroyed. Any unused frozen semen , remains the property of Saltriver Performance Horses and may not be used on any other mare or in any other season on the same mare , without written permission of Saltriver Performance Horses.(written permission will only be given where a further breeding contract is signed and the appropriate fees paid)Any attempt to use to use any portion of any semen shipped to the mare owner , to bred any other mare than the said mare shall automatically terminate all obligations of Saltriver Performance Horses. All mare owners rights shall be forfeited and mare owner will be liable for all costs incurred, included breeding fees for every unapproved mare inseminated, regardless whether a foal is produced or not.

Notes for mare owners :

If you are using shipped semen you should advise Saltriver as soon as your mare comes in season, so we have at least 48 hours notice for the possible shipment of semen. A firm order for semen must be made at least 24 hours prior to collection time, and preferably the evening prior to ,or by 8.30 Western standard time on the day of shipment.

Remember that semen will be shipped only on Monday /Wednesday and Fridays. Shipments outside these days and hours may be requested , but not necessarily be made available – so plan ahead.
